loE believes that a person intent on learning and developing skills does so irrespective of formal classes or formal examinations. Hence the Institute will offer students courses to undergo the same at his/her pace. The Institute will conduct its courses and issue Course Completion certificates after evaluating the candidates on the basis of the following:

- Written assignments to be submitted throughout the duration of the course
- Oral interview and group discussion in the presence of mentors and reputed entrepreneurs/management consultants


